That when in the period of ten working days, it is agreed that they will not proceed to totally or partially carry out the proposed rectifications, this will be notified to the affected party so that, whenever necessary, they may request the procedural protection of the Spanish Data Protection Agency within the scope of section 18 of the aforementioned Organic Law 15/1999.

That if the rectified data was previously communicated, the file manager is notified of the cancellation that has been carried out so that they may also proceed to carry out any necessary corrections to respect their duty to the quality of data, regarding section 4 of the aforementioned Organic Law 15/1999.
